- ____ Impact Fees (water/sewer) must be paid prior to building permit being issued.
- ____ Availability of water and sewer.
- ____ Site Plan (drawn to scale indicating dimensions, lot lines, building lines, location of building, driveways, & parking.
- ____ Driveway is required on plans if less than One (1) acre of land
- ____ WPI-1 from a Windstorm Engineer.
- ____ Two (2) Copies of Engineer Sealed and Signed Foundation Plan.
- ____ Two (2) sets of full size detailed building plans, including structural details.
- ____ One (1) small set-8½ x 11 or 8½ x 14 (may be sent by email to: building@inglesidetx.gov)
- ____ Signed Residential or Commercial Energy Check Report to be completed by Energy Inspector
- ____ Mechanical Project Summary Report – with layout
- ____ Elevation Certificate to show the foundation floor 12” above BFE or street (whichever is higher). Is lot in Flood Plain?
- ____ Survey, if deemed necessary by the Building Official.
- ____ TDLR# (over 50,000) **Commercial Projects only.**
- ____ Engineered Drainage plan, if deemed necessary by the Building Official.

The City of Ingleside does not accept construction material waste. All construction material waste must be removed and properly disposed of at the expense of the owner/contractor. Porta Potty & construction material waste trailer/dumpster is required on site during construction.

The City of Ingleside requires a copy of Engineer’s final report (WPI-2), a certificate of Termite pre-treat report, and final RESNET/HERS rating certificate prior to C of O being issued.
