I. CALL THE MEETING TO ORDER

IV. OTHER BUSINESS

(A) Public Hearing concerning an application filed by Tom Mannering to rezone LT 11 BLK F Burton & Danforth Subdivision. Mr. Mannering is requesting to be allowed to change the zoning from its present classification of R-1 (Single Family Residential) & R-3 (Three & Four Family Residential) to M (Multi-Family).
